Municipal Budget Adopted

The Combined Locks Village Board has adopted a \$5.382 million budget for 2023 municipal operations, capital projects and purchases, and debt payments. It includes a tax levy of \$1,825,970. This levy is a 1.15% increase over the previous year and equates to a tax rate of \$5.09 per \$1000 of assessed value. This is a \$0.03 increase over the 2021 tax rate. A property owner whose home is assessed at \$200,000 will pay \$6.00 more for municipal services than in the previous year. Your property tax bill also includes a number of other governmental agencies with the authority to levy a tax in order to support their activities and services. Those agencies include the County, the State, the School District, and the Technical College. A comparison of each jurisdiction's tax rate from 2021 to 2022 is printed on your tax bill.

Tax Credits and Special Charges

<u>Lottery Credit</u>: Check your 2022 real estate tax bill to see if you received a lottery credit. Properties in the Kaukauna School District receive a \$167.76 credit, and properties in the Kimberly School District receive a \$155.02 credit. Residents who owned their homes as of 01/01/22 and use it as their primary residence also as of 01/01/22 are eligible for the credit. If the credit is not on your tax bill already, it is not too late to claim it. Claim forms are available at the Municipal Clerk's Office. Please call or stop in for details.

<u>Storm Water Charge:</u> Storm water charges are added to all parcels in the Village in order to pay for storm water management as required by the Wisconsin DNR. The Storm Water Charge for the 2022 tax bill is \$130 per ERU. The value of duplex, unimproved and non-residential properties is based on a percentage of the value of one ERU. These charges are necessary to fund the DNR requirements to reduce sediment and phosphorous in the Fox River and in Garners Creek.

<u>Garbage Charge</u>: Garbage charges are added to each parcel in the Village according to the size and number of garbage carts at the property. Each 64-gallon cart is \$125, and each 96-gallon cart is \$179 for the 2022 tax bills. These charges cover the landfill and recycling expenses, replacement carts, maintenance on the trash truck, and allows for a reserve fund to replace the trash trucks when it becomes necessary.



Important Tax Payment Dates

- ❖ If you intend to pay your property taxes in full, payment must be made (or postmarked) by January 31, 2023.
- If you intend to pay your property taxes by installments, the first installment must be made (or postmarked) by January 31, 2023, payable to Village of Combined Locks. The second installment must be paid to the Outagamie County Treasurer by July 31, 2023.
- First installment or full property tax payments can be made in person by January 31, 2023 at either of these locations:

You may also use the Night Deposit Box located west of the Civic Center's main doors.

2023 Dog Licenses Available

The 2023 dog licenses are available for purchase. The cost is \$7 for spayed or neutered pets, or \$12 for unaltered pets. A current rabies vaccine showing an expiration date of later than 04/01/2023 is required to purchase a license. Proof that your pet is spayed or neutered is also required.






2023 Yard Waste Permits Available

Residents who use the Yard Waste Site to drop off grass clippings, SMALL amounts of SMALL brush, garden debris, or waste oil are required to have a 2023 permit. The permits are available to purchase at the Clerk's Office. The fee is \$10. The permit is needed to help the Village keep costs down and prevent non-residents from using this taxpayer funded service.











Trash & Recycling Reminders

Trash and recycling needs to be curbside by 6:00am on collection days. During winter months, do not place your carts in the street or on top of snow banks; instead place them in your driveway apron. One cart on each side of the apron works best for automated collection. Placing the carts in the street interferes with snow plowing and snow removal.

Always place your cart at least 4 feet away from any other object - including mailboxes. Carts must be placed with the arrows pointing toward the road. Your cooperation helps us to deliver this essential service in an efficient manner. Thank you for your cooperation.




Christmas Week

Snow Removal Practices

Section 6-2-7 of the municipal code explains that it is the responsibility of the owner, occupant, or person in charge of any parcel or lot which fronts upon or abuts any sidewalk, to keep the sidewalk clear of snow and ice: and to remove snow and ice from the sidewalk within 48 hours after a snowfall. In the event that ice forms on the sidewalk in such a manner that it cannot be removed, the owner, occupant, or person in charge is to sprinkle salt, sand, and or other melting substance to permit safe travel by pedestrians.

The Village no longer sends out warning letters to those property owners or residents who do not have their sidewalks cleared in a timely manner. The Village will act to have snow removed from the sidewalks that are not shoveled in a timely manner and bill the costs as a special assessment to the property.

Prohibited Snow Removal Practices

- We using a private vehicle or snow blower to push snow/ice onto a public street or sidewalk or manually shoveling snow/ice onto a public street or sidewalk
- Shoveling or blowing snow on top of a fire hydrant

If you contract for snow removal, make sure your contractor is aware of these rules.









Mail Box Damage

No matter how careful our snow plow operators are, mailboxes might get damaged during the snow season. If a mailbox is damaged due to operator error, the operator will notify the Director of Public Works. He will report the location of the incident and the amount of damage. The Department of Public Works may choose to replace the damaged mailbox with a standard mailbox approved by the US Postal Service. The Department of Public Works may, upon request of the property owner, provide not more than \$75 towards the replacement cost of said mailbox. A property owner who installs a decorative mailbox or decorative material within the road

right of way does so at his or her own risk, and the Department of Public

Works shall not be responsible for damages.

Fire Hydrants

A few minutes of your time after each snowfall to clear the hydrant of snow means that the Firefighters can more effectively fight a fire in your neighborhood. Thank you for your help.







Winter Parking

Parking on Village streets is <u>prohibited from 2:00am to 6:00am from December 1 through April 1.</u> For the occasional guest parking, please contact the Outagamie County Sheriff's Office at 920-832-5000 for a temporary exception. Vehicles must not be parked in such a manner so as to obstruct the public sidewalk.






Large Rubbish Collection Reminders

Election Security: wi.gov domain

State and local election offices are increasingly tasked with countering false or misleading information about an election on top of administering an election. Moving to the wi.gov domain is one concrete response election officials can take to address this problem.

The Village of Combined Locks has recently updated our domain for email (and our website) to combinedlocks.wi.gov. The Wisconsin Elections Commission (WEC) and the U.S. Cybersecurity and Infrastructure Security Agency (CISA) recommend that municipal and county government emails, especially those used for election related information, should be easily identifiable as government entities. Obtaining the wi.gov email domain increases election security and trust in official election communications.

2023 PARK RENTAL

Lindberg Park: Rental fee \$50 for residents; \$100 for non-residents

Memorial Park: Rental fee \$100 for residents; \$200 for non-residents

Van Zeeland Park: Rental fee \$100 for residents; \$200 for non-residents

A separate security deposit is also required for all park rentals. Residents of Combined Locks may reserve parks as of 11/01/22.

Non-residents may reserve parks as of 04/01/23.

The Mark Van Thiel Room is available for family parties, bridal and baby showers, birthday parties, etc. It has a capacity for 75 people and includes a small kitchen with refrigerator, sink and stove. The rental fee for residents is \$100. The rental fee for non-residents is \$150. A separate security deposit is also required for all rentals.

Residents of Combined Locks may request 2023 reservations as of 11/01/22. Non-residents may request 2023 reservations as of 01/03/23.






2023 GOLDEN AGERS ROOM RENTAL

The Golden Agers Room is available for smaller (maximum 30 people) family parties, bridal and baby showers, birthday parties, etc. It includes a refrigerator, counter space and a sink. The rental fee for residents is \$75. The rental fee for non-residents is \$150. A separate security deposit is also required for all rentals.

Residents of Combined Locks may request 2023 reservations as of 11/01/22. Non-residents may request 2023 reservations as of 01/03/23.





FIREWOOD CUTTING

During the course of this winter, we will be cutting down numerous Ash trees in the Combined Locks parks. 

Ice and Snow Control

We can have safe walkways in the winter and cleaner water all year round.

Winter in Northeast Wisconsin is a great time for outdoor fun, like ice fishing, ice skating, sledding and skiing. Here, winter also means mountains of snow to shovel and layers of ice to remove from driveways and sidewalks. We often try to make ice removal easier by using products like salt and sand to melt the snow and ice. Many people do not realize that these products are harming local waters and the animals that rely on them. When the ice and snow melt, the salt and chemicals flow into street drains that lead directly to rivers and lakes.

Shovel Often and Early

Shoveling often during and immediately following the storm removes the snow from walkway and driveways before it gets packed down by tires and feet. The most important part of deicing is removing as much snow as possible before applying salt or sand – it's also great exercise!

Use only the recommended amount.
Throwing down more salt will not speed up the melting process.

Make the most of the Salt you use.

It is not always necessary to see bare pavement to have a safe winter surface. Ask yourself if it is necessary that the snow or ice be removed. For salt to be effective, air

temperature needs to be warmer than the surface temperature of the area you want to treat. A little goes a long way. Use only the recommended amount. Throwing down more salt will not speed up the melting

process. Use only enough deicer to break the bond between the ice and the pavement, then remove the remaining slush by showing.



Limit the amount of sand you use

Sand provides traction. It does not melt ice. Sand, although not chemical, contributes to polluting our local waters. It adds to the excess sediment that is entering waterways, eliminating important habitat for aquatic plants and animals. Sand does play a role in winter road management. It often used by municipalities on roads to help maintain traction. Since ice removal is typically the concern of homeowners, sand may not be necessary.
