DPW Co-Director Keith Weyenberg discussed the utility pole location issue with the trustees at the 03/18/25 meeting. He met with Kaukauna Utilities on 03/20/25 to discuss options for the pole locations on Park Street. KU representatives believe that the cost to place power underground in the 400 block of Park Street is an estimated \$100,000.


The Village is required to follow WI Department of Transportation standards for the road construction because of the \$400,000 grant it will be receiving. 5' integral sidewalks are not allowed per DOT standards.


Option 1


Reduce sidewalk blocks to 4' wide instead of 5' wide as required by ordinance. This will allow for a small terrace for utility poles.

Option 2

Eliminate sidewalks between Lindberg Park and 401 Park Street.







Administrator Giese is requesting a budget amendment to replace the in-floor heat boiler at the Public Works Building. The quote from Energy Controls is \$12,575. The final cost could be higher if electrical services are needed.

The Buildings Maintenance Fund has a balance of \$60,998. If approved, the cost of the boiler replacement would be paid from this reserve account.

ORDINANCE NUMBER 1, SERIES OF 2025

AN ORDINANCE AMENDING SECTIONS 215-6 B AND 215-6 C "RESTRICTIONS ON KEEPING DOGS, CATS, FOWL, AND OTHER ANIMALS"

BE IT ORDAINED by the Village Board of Trustees, Village of Combined Locks, Outagamie County, Wisconsin as follows:

1. Ordinance Sections 215-6 B and 215-6 C as set forth in Exhibit 1 attached hereto is hereby amended as set forth below.

§ 215-6. Restrictions on keeping of dogs, cats, fowl and other animals.

ANIMALS

- A. Restrictions. It shall be unlawful for any person within the Village of Combined Locks to own, harbor or keep any dog, cat, fowl or other animal which has been determined to be a public nuisance as defined in § 215-1 or allow the animal to run at large in the Village.
- B. Required confinement or restraint. The owner or custodian of any animal shall confine or restrain the animal so that the unprovoked animal does not run at large, attack, molest, or cause bodily harm to any person or other animal.
- C. Responsibility of owners and custodians. All owners and custodians shall exercise proper care and control of their animals under their ownership, possession, or custody to prevent them from becoming a public nuisance animal.
 - (1) All dogs, cats or other domestic animals shall be kept on a leash, which is under the control of animal's owner or custodian, at all times when off the premises of its owner.
- D. Special female animal precautions. Every female dog or cat in heat shall be confined in a building or secure enclosure, or otherwise restrained, in such a manner that such female dog or cat cannot come into contact with another unneutered male of the same species, except for planned breeding.
- E. Owner's liability for damage caused by dogs; penalties. The provisions of § 174.02, Wis. Stats., relating to the owner's liability for damage caused by dogs together with the penalties therein set forth are hereby adopted and incorporated herein by reference.

Severability. The provisions of this ordinance are declared to be severable, and if any provision of this ordinance is held to be invalid or unconstitutional, or if the application of this ordinance to any person or circumstances is invalid or unconstitutional, such invalidity or unconstitutionality shall not affect any remaining provisions or applications of this ordinance.

Effective Date. This Ordinance shall take effect upon passage and publication as provided by law.

EXHIBIT 1

Amended 215-6 B and 215-6 C

§ 215-6. Restrictions on keeping of dogs, cats, fowl and other animals.

ANIMALS

- E. Owner's liability for damage caused by dogs; penalties. The provisions of § 174.02, Wis. Stats., relating to the owner's liability for damage caused by dogs together with the penalties therein set forth are hereby adopted and incorporated herein by reference.
